Energy Assistance Services - For low-income households, the Organization offers assistance with utility bill payments and weatherization services to improve energy efficiency as well as critical heating and cooling services to vulnerable populations during severe weather emergencies.

The Organization served 2,275 households with utility bill payment assistance.

The Organization processed 4,029 energy management assistance program applications.

Youth Services - The Organization offers a variety of educational opportunities, job training, skills enhancement classes, and support systems to eligible participants.

The Organization provided after-school programs to over 1,000 students each day saving families over \$500,000 in child care expenses.

During the winter break from school, the Organization provided enrichment programs to over 200 students.

Lunch was made available to 80 financially challenged youth during the summer school break.

Community Advocacy and Family Services - Through its collaborative efforts with other organizations and partner agencies, the Organization provides a gateway for individuals and families to have convenient access to a coordinated continuum of comprehensive programs and services.

The Organization's gardening program provided organic food to 1,700 people each week.

The Organization provided income tax preparation services to 200 families.

We assisted 58 people by helping to pay their rent or utility bills. We purchased clothing, tools, and bus tokens to help our clients become self-sufficient.
